  - Thursday, October 19th from 5 – 8 pm
  - Friday, October 20th from noon – 8 pm
  - NO REFUNDS
- Based on participation, we may not be utilizing the whole campground, therefore you are not guaranteed your traditional, fair camping spot. However, on the reservation form you may list your preferred neighbors.
- Campfires, in rings or containers designated for such use, are permitted during this campout!

- Movie Night: Friday evening at 8:00 pm in the campground

## CAMPGROUND RULES

1. Any person who violates any of the following or special rules pertaining to camping area will forfeit all privileges and will be subject to such penalty as the Board may order.
2. No trailers, campers, tents, or vehicles use for living purposes during the campout are allowed in the campground before designated date and must be removed by Sunday at noon.
3. Trailers, campers, tents or other vehicles used for living purpose during the campout must be parked in designated camping area. Owner of such trailers, campers, tents, or other vehicles used for living purpose must receive a receipt from Director-in-charge.
4. All trailers, campers, tents or other sleeping units to be occupied by a youth under 18 must be registered by their parent or legal guardian who will be responsible for their conduct at the fair.
5. All music, noise, or any other disturbances will stop at midnight. Curfew rules will be in effect at 12:01 a.m. each morning and last until 9 a.m.
6. All premises around campsite must be kept clean and sanitary. Trash cans will be provided through-out the area.
7. No dumping of any sewage or gray water holding tanks on the ground will be permitted at any time. A dump station is provided. Lawrence County Agricultural Society will not be held responsible for any or all fines issued by EPA, Lawrence County Health Department, or any other agency for dumping in ditch or on ground.
8. No alcoholic beverages will be allowed in camping area outside of camping units. In agreement with Ohio State Law, alcoholic consumption will not be allowed under 21.
9. Each and every trailer, camper, tent or any other living unit will have a numbered space. This unit will occupy this space only.
10. The Director-in-charge has the right to assign each of the living units and change sites to accommodate spaces. Your traditional fair camping spot is not guaranteed; as pending on reservations the full campground may not be utilized.
11. Campfires, in a ring or container made for such use, are permitted at each campsite.
12. No firearms or fireworks are allowed in the fairgrounds camping area.
13. The Society reserves the final and absolute right to interpret these rules and arbitrarily settle and determine all matter, question, and differences in regard thereto, or otherwise arising out of or connected with, or incident to the Lawrence County Agricultural Society; and the right to amend or add to these rules as its judgement may determine. A camper who violates any of the rules will forfeit all privileges and will be subject to such penalty as the Lawrence County Agricultural Society may order.
